

Devin Stevenson Scholarship Fund Application

Scholarship Overview:

The Devin Stevenson Scholarship Fund is dedicated to supporting high school students who demonstrate outstanding achievements in academics and sports. Our goal is to empower students to pursue higher education while promoting conflict resolution and community safety, including gun safety. This scholarship is open to students who embody leadership, academic excellence, and athletic achievement.

Scholarship Award:

Up to 2 scholarships will be awarded annually.

Each scholarship recipient will receive \$1,000 to be used toward tuition, fees, and other academic expenses at a college or university of their choice.

Eligibility Criteria:

To be considered for the Devin Stevenson Scholarship Fund, applicants must meet the following criteria:

- Be a current high school senior attending a school in the Greater Houston area.
- Have a cumulative GPA of at least 3.5 on a 4.0 scale.
- Demonstrate involvement in high school sports (athletics participation at any level is accepted).
- Plan to attend an accredited college or university following graduation.
- Submit an essay on conflict resolution and community engagement (details below).
- Demonstrate financial need (as supported by documents or a brief explanation).

Essays should be typed, double-spaced, and submitted as a PDF or Word document. Applicants are encouraged to share personal experiences, show how they plan to apply the lessons learned,

and discuss their role in creating safer communities, particularly in reducing violence and promoting conflict resolution.

Required Documents:

- Completed Application Form.
- Official High School Transcript (including current GPA).
- One Letter of Recommendation from a coach, teacher, or community leader who can speak to your academic and athletic achievements, leadership abilities, and character.
- Essay on Conflict Resolution (see essay prompt above).

Application Deadline:

All application materials must be submitted by **April 1, 2025**. Late applications will not be considered.
